**Subject: Compliance of Syn-Tech Ltd. Products to Prohibited Material List for REACH and RoHS.**

Syn-Tech Ltd. confirms that its products contain no substances from the following prohibited list, for **REACH SVHC** as of January 15, 2018, Regulation (EC) No 1907/2006 of the European Parliament and of the Council of 18 December, 2006 concerning the Registration, Evaluation, Authorization and Restriction of Chemical (REACH) and **RoHS2** Ref: Directive 2002/95/EC RoHS Directive and with Directive 2011/65/EU of the European Parliament and of the Council of 8 June 2011. Addendum: Updated SVHC list on 1/15/2018.

To the best of Syn-Tech Ltd. knowledge and belief, Syn-Tech Ltd. products do not contain any of the substances which are on the candidate list of substances of very high concern or recommended for inclusion in Annex XIV at the time of our supply to your company above the reporting threshold of 0.1%. We are unaware of any potential sources for the introduction of any substances of concern from the manufacturing and packaging processes utilized, nor from the packaging components themselves. However, Syn-Tech Ltd. does not specifically analyze for the presence of substances of very high concern. This information is provided in good faith and is believed accurate as of the date of this letter based on a review of current composition and information supplied by vendors. However, no warranty with regard to the information contained herein is expressed or implied and Syn-Tech Ltd. expressly disclaims any liability whatsoever howsoever arising from or in connection with this letter.

**1. Restriction of Hazardous Substances (RoHS) (Directive 2011/65/EU)**

RoHS is the restriction of the following six substances in electronic and electrical equipment (EEE):

- Lead (.1%)
- Mercury (.1%)
- Cadmium (.01%)
- Hexavalent Chromium (.1%)
- Polybrominated biphenyls (.1%)
- Polybrominated diphenyl ethers (PBDE) (.1%)

NOTE: The European Union has proposed new legislation as referenced in (EU) 2015/863 which includes the additional four substances restricted in RoHS. These provisions go into effect on July 22, 2019, for medical devices this is extended to July 22, 2021.

- Bis (2-ethylhexyl) phthalate (DEHP) (.1%)
- Butyl benzyl phthalate (BBP) (.1%)
- Dibutyl phthalate (DBP) (.1%)
- Diisobutyl phthalate (DIBP) (.1%)
